No.F.20016/24/08-FCS&CA/Part : In exercise of the powers conferred under sub-sections (1) & (2) of Section 28 and sub-sections (1) & (3) of Section 42 of the Consumer Protection Act, 2019 [35 of 2019] and in pursuance of the instructions issued by the Central Government vide F.No.J-9/5/2020-CPU dated 16.03.2021, the Government of Mizoram hereby establishes the District Consumer Disputes Redressal Commissions and the State Consumer Disputes Redressal Commission, to be known as District Commission and State Commission respectively, with effect from the 20th July, 2020.

The Presidents and Members of the State Commission and the District Commissions appointed immediately before the commencement of the Consumer Protection Act, 2019 shall continue to hold office as Presidents and Members of the State Commission and District Commissions till the completion of the respective terms for which they have been appointed as provided in Section 31 and Section 45 of the said Act.

This supersedes this Department's notification issued vide No.F.20016/24/08-FCS&CA/Part dated 1st March, 2021.
