NOTIFICATION

In exercise of the powers conferred under section 30 and section 44 read with clauses (h) and (m) of sub-section (2) of section 102 of the Consumer Protection Act, 2019 (35 of 2019), the Government of Mizoram hereby makes the following rules further to amend the Mizoram Consumer Protection (Salary, allowances and conditions of service of President and Members of the State Commission and District Commission) Rules, 2021, namely:

- 1. Short title and commencement.-
- (1) These rules may be called the 'Mizoram Consumer Protection (Salary, allowances and conditions of service of President and Members of the State Commission and District Commission) (Amendment) Rules, 2024'.
- (2) They shall come into force on the date of publication in the Official Gazette.
- 2. Amendment of rule 4. -

In sub-rule (4) of rule 4 of the Mizoram Consumer Protection (Salary, allowances and conditions of service of President and Members of the State Commission and District Commission) Rules, 2021, for the third provisio shall be substituted, namely:-

"Provided further also that the State Government may appoint a member of the State Commission on 'part-time' basis on payment of sitting allowance of Rs. 4,500/-(Rupees four thousand five hundred) only per sitting per day along with 'Conveyance Allowance' of Rs. 500/-(Rupees five hundred) only per day of sitting for the same station."
